With the winter precipitation in the area, UNC Transportation & Parking is making the following announcements.

PARKING:

Parking regulations are in effect on Wednesday, January 14—even in lots where gates are raised—**beginning at 10 a.m.** This includes Dogwood Deck, which is expressly reserved for patients and visitors only. Affiliated personnel parking in the Dogwood Deck must display a valid Dogwood Deck permit.

During adverse weather threats, top levels of the parking decks are often closed and will remain closed until they can be cleared for normal operations or the threat of adverse weather has subsided.

TRANSPORTATION:

Park and Ride

The S11 Lots along Skipper Bowles Drive are available to commuters impacted by Park & Ride transit route delays. Because Triangle Transit routes are delayed until 10 a.m. and most Chapel Hill Transit will still be operational, commuters may park in the UNC / Town Park & Ride Lots:

Point-to-Point

Point-to-Point will begin operating normally at 9 a.m. and will continue to operate as long as road conditions warrant.

Chapel Hill Transit:

Chapel Hill Transit (CHT) is running normal routes and schedules on Wednesday morning, January 14 as long as the streets are safe for travel. Some delays should be expected. If you must travel, be safe, dress warmly and expect delays.

FOR FURTHER INFORMATION:

UNC Transportation & Parking will continue to monitor road conditions, parking and commuter conditions and will make adjustments to parking and / or Point-to-Point operations as appropriate. Changes and updates to UNC’s operational status are also prominently noted on the Transportation & Parking website (<http://move.unc.edu>) and on the UNC Public Safety website (www.dps.unc.edu) as appropriate, and campus adverse weather information will be available via Alert Carolina at <http://alertcarolina.unc.edu>.

Changes to the University’s operational status and other emergency information will be communicated using means including campus-wide e-mail and voice mail (only for campus land lines), the Adverse Weather and Emergency Phone Line at (919) 843-1234, the Travelers’ Information radio system (1610 AM), and the University Access Channel (Chapel Hill Time Warner Cable Channel 4) along with other campus television channels.
